FINAL REMINDERS:



Oak Forest Drive is a residential street with a speed limit of 25mph. There are many families with young children in the subdivision again. Please be mindful as you drive in and out of our sub.

Our neighborhood website has a link to The Declarations of Covenants, Conditions and Restrictions for the Woodlands South subdivision, issued in January, 2004, by Pulte Land Company. Sections 6.17 and 7.1 specifically call out the fact that fences of any kind are not to be erected on any Lot unless approved by the ACC for the sole purpose of protecting a pool.
